

1 September is "Disaster Prevention Day"

Japan is a country that has experienced many unprecedented catastrophes such as typhoons, storm surges, tsunami, earthquakes, etc.

After the "Great Kanto Earthquake" on 1 September 1923, that resulted in more than 100,000 dead/missing people, 1 September was designated as the "Disaster Prevention Day" for people to prepare for disasters. The week including the "Disaster Prevention Day" is called "Disaster Prevention Week", and evacuation drills are carried out in many organizations and schools. Please think about what to do in case of emergency.

➤ Application "Safety tips" to notify disaster prevention information developed under the supervision of the Tourism Agency

It is a free application that estimates, immediately after an earthquake, the time and the intensity anticipated at various places, and disseminates emergency alert, tsunami information, eruption information, special warning, heat stroke information, missile launch etc. at the earliest notice. It is available in English, Chinese (Traditional and Simplified *), Korean and Japanese.

* Traditional Chinese characters are used since ancient times and are currently used in Japan, Taiwan, Singapore and other countries. Simplified characters is a simplified notation mainly used in China.

➤ Passport-sized portable "Disaster Manual"

A "Disaster Manual" is provided for foreigners living in Ibaraki prefecture in 10 languages. (Japanese, English, Chinese, Korean, Portuguese, Thai, Tagalog, Spanish, Indonesian and Vietnamese). It is a handy booklet filled with information on what to do in case of disaster and preparation for disaster. In addition to downloading and printing out the PDF from Tsukuba city's and Ibaraki prefecture's homepage, we also have them printed out at the City Hall. Please be sure to use them.

City Tax Payment Deadlines

Please pay taxes before the deadline as given below. If it is difficult to pay taxes in time, please consult before the deadline. 1 October (Mon): National Health Insurance (NHI) Tax (3rd term)

31 October (Wed): Municipal Tax/Prefectural Tax (3rd term), and NHI Tax (4th term)

30 November (Fri): NHI Tax (5th term)

*City/Prefectural Tax is a tax calculated based on your income during the previous year and to be paid to your municipality as of 1 January of every year. It is different from Income Tax.


*The National Health Insurance (NHI) is an insurance which should be joined by all except those who are covered by Employees' Health Insurance or other social insurance. The

insurance premium (NHI Tax) is calculated based on income during the previous year and the number of family members who are insured by NHI.

About National Health Insurance (NHI)

In Japan, there is a Medical Insurance System in that a part of expense of medical treatment (in some cases the whole expense) is paid to the doctors from the insurance, so that people may get medical treatment at ease without worrying about economic situation of the family. Medical Insurance is roughly divided into three groups: Employee Insurance to which employed people subscribe; NHI to which those who are not insured by Employee Insurance subscribe; Latter-stage Elderly Medical Care System to which people over 75 years subscribe. All people must subscribe to one of these.



Employee Insurance varies depending on the company size and the type of industry. NHI is administered by the prefectures. NHI is calculated based on the number of household members who are subscribed to it and income during the previous year. If there is any change in the number of people who are subscribed to NHI as a result of childbirth or employment or unemployment, it will be recalculated in the middle of the fiscal year. Also, to calculate NHI Tax, it is necessary to declare the incomes of the household head and all subscribers. Otherwise, it is not only impossible to calculate the correct insurance Tax, but also to apply for various systems for Tax reduction and exemption systems, and to determine high medical expenses. In mid-July an insurance payment slip was sent out from Tsukuba city to all subscribers of NHI and Latter-stage Elderly Medical Care System. The obligation to pay NHI Tax is on the household head. Even if the head of household is not subscribed

to NHI, tax notice will be sent out to the head of household.

Please pay it monthly in 9 installments over the year from July to March of the following year. The deadline for the payments is the last day of each month or the following Monday, if the date falls on a weekend or a holiday. (The deadline for December is the 25th.) Those who are over 65 years old and are subscribed to NHI, the installments will be deducted from the received pension if conditions are met. If you are a member of NHI but do not have a payment slip or it is difficult for you to pay, please consult at the City Hall.

>NHI Tax Reduction System

If the total income of the head of household and subscribers during the previous year falls below the standard, part of NHI Tax will be reduced by 20% to 70%. Although you do not need to apply for this reduction, you do need to declare the income of the head of household and all subscribers.

■ NHI Tax Reduction System for Involuntary Unemployed People

NHI Tax reduction system is applied for those who have been forced to leave work due to company restructuring or bankruptcy and who are enrolled in NHI and have "unemployment insurance qualification certificate".

➤NHI Tax Exemption System

■ Exemption of NHI Tax

In Tsukuba City, if payment of NHI tax is difficult due to unavoidable circumstances, tax emption system is available under some conditions. Please contact us.

■ Exemption of the NHI Partial Charge (self-payment at medical institution window)

If income falls below a certain amount due to unavoidable circumstances such as disasters, unemployment or bankruptcy, the partial charge to be paid at medical institutions can be exempted under some conditions, if so requested.

➤ Notification of Subscription and Cancellation of NHI

Do not forget to notify subscription and cancel of NHI. If the notification of subscription is delayed, you will have to pay the insurance tax back to the time when qualified for NHI subscription. In addition, all medical expenses during that time be borne by you. If the notification of cancellation is delayed, if you receive any medical treatment using NHI after qualification loss, medical expenses that were borne by NHI shall be returned. In addition, insurance tax payment may be duplicated.

■ When to join NHI

When moving in from another municipality

When quitting any health insurance at working place

When you are no longer a dependent of family health insurance When a child is born (You can apply for Childbirth and Childcare Lump-sum Grant)

When you stop receiving livelihood protection

When foreign nationals first come to Japan

■ When to cancel NHI

When moving out to another municipality When joining health insurance at working place

When you become a dependent of family health insurance

When the insured person of NHI dies

When you start receiving NHI protection

■ A notification is also necessary in the following cases

When you change the address, head of household, name etc. When dividing or uniting households

When transferring your address to another municipality for study or institutionalization

When you lost insurance card

Please notify us within 14 days after the necessity occurs!

*Please prepare My Number (personal number) card or the notice card when reporting.

*At the time of subscription, NHI certificate will be issued to each person to certify the person is insured by NHI. Please treat it carefully.

About National Pension

National Pension System not only provides basic pension for old age, but also offers support of lives of victims of accident/illness from being impaired. In Japan, everybody between ages 20 and 60 is supposed to subscribe to it.

➤ About "Exemption System" and "Postponement System" for NHI Tax

■ Exemption System (based on the examination of your/ spouse's/household head's income during previous year)

If payment of Tax of 16,340 yen every month is difficult due to economic reasons etc., the entire tax or a part of the tax is exempted if application gets approved.

If you wish special exemption due to unemployment, you need to attach "Unemployment Insurance Separation Certificate" or "Unemployment Insurance Qualification Certificate"

Exemption Categories (FV 2018)

Category	Insurance Fee (monthly)
Full Exemption	0 yen
3/4 Exemption	4,090 yen
Half Exemption	8,170 yen
1/4 Exemption	12,260 yen

■ Payment Postponement System (based on the examination of your/spouse's income during previous year)

Those under the age of 50 can also use Postponement System besides Exemption System. Payment of insurance tax will be postponed for a certain period of time upon receiving approval of your application.

■ Student Payment Special Exception System (based on the examination of income during previous year only)

When students receive approval of their applications, payment of insurance tax will be postponed for a certain period.

For this application you will need to attach some document that proves you being a student during the application period.

In addition, students can not apply for Exemption System or Payment Postponement System.

■ Statutory Exemption

Those who are receiving disability pension and livelihood assistance by the Livelihood Protection Law are exempted from payment of insurance fee.

*Exemption System/ Payment Postponement System/ Student Payment Special Exception System can be applied retroactively for the past 2 years (starting 2 years and 1 month before the application month); (For people between 30 and 50 years old Payment Postponement will be applied from July 2016). The application period can be shortened if the application is delayed. Please apply promptly.

[Application Period] From July to June next year

*Regarding retroactive applications, it is up to 2 years and 1 month back

[Necessities for the Procedure]

(1) Pension Handbook, and something which shows basic pension number (payment form etc.) or My Number card.

In the case of a notification card, something to confirm identity, for example, driver's license, passport etc. is needed.

(2) Seal (not needed when signing personally)

- ③In case of unemployment, one of the following documents is necessary. You can apply from the month before the month of leaving company up to June 2 years later.
- ■Unemployment Insurance Separation Certificate (or a copy)
- ■Unemployment Insurance Qualification Certificate (or a copy)
- ■Unemployment Insurance Holder Qualification Loss Confirmation Notice (or a copy)
- ■Unemployment Insurance Qualification Acquisition Notification Inquiry Reply (or a copy)

*For unemployed people who cannot apply for Unemployment Insurance, please contact the National Pension Division.

[Application Method]

Please apply at Medical Welfare and Pension Division or at branch offices.

You can also fill out the application form downloaded from the Japan Pension Service HP and apply by mail at Medical Welfare and Pension Division or Tsuchiura Pension Office.

in case of the reason being unemployment, please send also the documents mentioned in (3) above.

➤Insurance Fee Additional Payments

Regarding the period of exemption or postponement of payment of insurance fee, you can pay it retroactively within the next 10 years. We recommend you to pay this additional fee in order to bring the future annual amount to be closer to full. However, if you pay 3 years after the year when you received the approval, the insurance fee is added to the original amount. If you want to make additional payments, the application at a pension office is required.

*Further details will be announced in October at the news section of Tsukuba Municipal Multilingual HP (in English/Chinese/Korean/Simple Japanese)



The reception from 1 March will be for entry from May.
