*Municipal/Prefectural Tax, also known as Resident Tax, is a

tax representing the combination of Individual Citizen Tax and Prefectural Tax. Resident Tax is obligatory for residents who live in Tsukuba city as of 1 January 2018. It is calculated based on your income during the previous year.

*National Health Insurance Tax is a tax paid by heads of households that have National Health Insurance members. The National Health Insurance Tax, along with subsidies from the prefectures, is used for medical expenses when you are sick or injured, as well as when your child is born or somebody in your family dies.

*Fixed Property Tax is a city tax paid by those who own land, houses, depreciable properties (collectively referred to as "Fixed Property") in Tsukuba city as of 1 January 2018 according to the fixed property value.

Did you apply for Child's Marufuku?

Medical Welfare Expenses Payment System for infants and small children Child's Marufuku is a system that subsidizes medical expenses by public expenditures for a child who uses his health insurance card when going to a medical institution.

【Target ages】 From birth to the 3rd year of high school (until first 31 March after turning 18 years old)

*Can be used by high school students only when hospitalized.

[Self-payment amount]

Outpatient – 600 yen/day, 2 times/month

Hospitalized – 300 yen/day, 3000 yen/month

*Self-payment is separate for different medical institutions

*No self-payment needed in drugstores

****For receiving Child's Marufuku the application is needed** Please make sure to apply when a child is born or when you move.

Required documents 1 Child's health insurance card, documents that display personal numbers of the parents and the child, a document to confirm the identity of the applicant, father's or mother's bankbook or cash card, consent form, and your seal.

[Application place] Medical Welfare and Pension Division or at all branch offices.

 \circ There is no income limit for junior high school students and below.

Children of junior high school age and below, even those who exceed the income limit in the prefecture system can still receive Child's Marufuku under the Tsukuba City original system, so all children of the relevant age are eligible for receiving Child's Marukufu.

It is necessary to confirm the income of the parents when applying. For people whose income of the targeted year cannot be confirmed in Tsukuba city, it might be necessary to present an income certificate or passport, so please contact us in advance.

Issue of Social Insurance Fee Reduction Certificate for People Who Do Year-end Adjustments and Final Tax Return Declarations

When doing year-end adjustments and final tax return declarations, people who have been paying National Health Insurance Tax, Late-stage Elderly Medical Insurance Fee, Nursing Care Insurance Fee, and National Pension Insurance Fee between 1 January and 31 December 2018 will be subjects to Social Insurance Fee Reduction.

1. Social Insurance Fee Reduction Certificate

In late January 2019 a "Social Insurance Fee Reduction Certificate" (postcard) will be sent out to those who have the obligation to pay (the head of household in case of NHI). *Not in time for Year-end Adjustments

This reduction certificate shows the amount paid within year 2018 (National Health Insurance Tax, Late-stage Elderly Medical Insurance Fee, Nursing Care Insurance Fee). Social Insurance Fee Reduction Certificate will not be issued if the taxes have not been paid.

1-1. If Social Insurance Fee Reduction Certificate is required before the shipping date, it can be issued at the following counters.

【Application counters】 Any representative division or at all branch offices

Required documents A document to confirm your identity (driver's license, etc.)

1-2. In the case of a person with special collection called "Tokubetsu Choshu", the amount paid in 2018 (National Health Insurance Tax, Late-stage Elderly Medical Insurance Fee, Nursing Care Insurance Fee) is stated in "Withholding Tax Collection Form" of Public Pension, etc. It will be sent out by Japan Pension Service in late January 2019. For those receiving Survivor Pension or Disability Pension and do not receive Withholding Tax Collection Form, Social Insurance Fee Reduction Certificate will be sent out from the city.

2. National Pension Insurance Fee

In early November "Social Insurance Fee (National Pension Insurance Fee) Reduction Certificate" (postcard) will be sent out by Japan Pension Service. Please contact us in case of need for reissue due to loss, etc.

*For those paying the insurance fee for the first time this year after 1 October due to joining from the middle of the year, etc., a similar certificate will be sent out in early February of the following year.

- 2. Those who plan to move to a different school district in the city before the end of March 2019
- 3. Those who live in and apply at a district where it is possible to change the designated school
- 4. Those who apply for a school outside of the designated school district

Information on Enrollment into Schools

Assignment of schools for enrollment

Schools for enrollment will be assigned by Board of Education based on your residence. You will be notified by the "Enrollment Notice" (postcard) that is planned to be sent out in late November. Please contact us if you have a child who you plan to enroll and have not received the "Enrollment Notice".

Application for Children Clubs for 2019

Children Clubs aim at sound growth of Elementary School and Compulsory Education School students in the city by providing children who do not have a daytime guardian with a place for playing and other activities after school hours.

[Working days and time]

On school days from after school until 18:30

During Spring/Summer/Winter Holidays 8:00-18:30

Closed on Saturday, Sunday, National Holidays and 29 December - 3 January

*Some Children Halls work until 19:00

【Target children】 Children who go to elementary school, feel comfortable in groups and whose guardian is away from home during daytime due to work etc. ※ Please note that because there are limitations on the number of children that can be accepted, we will give priority to children from lower grades.

[Fee] 4000 yen/month (2nd child and further 2000 yen) **
There is a reduction and exemption system

【Application documents】 Application guide and application forms are available at all Children Clubs, Children Halls and Child Centers, and Childcare Program Division counter. You can also download it from the city's HP.

*You will need to prepare attachment documents in advance. For more details please refer to the application guide.

【Application period 】 10 December 2018 (Monday) – 18 January 2019 (Friday)

Admission is based on the document examination. There may be a case where you cannot be admitted if applications exceed the capacity.

If you wish to apply to a private Children Club, application period, application method, fee, targeted elementary schools might differ depending on each club, so please contact such Children Clubs directly.

Now is the season when influenza is the most prevailing. Starting from 1 October subsidy for influenza vaccination for elderly people and children has started. Targets are people who are residents of the city and who meet the following requirements. A personal notification has been sent out to elderly people in late September who are eligible for influenza

vaccination. For more information please refer to the personal notification, city's HP, Life Plan Sukoyaka or contact us directly.

Influenza vaccination for elderly people (periodic)
 Period for subsidization 1 October 2018-31 January 2019
 Subsidy 1 Up to 2,000 yen. Up to 3,600 yen for those who receive Public Assistance

[Number of subsidies] 1 time

2. Influenza vaccination for children (optional)

【Period for Subsidization】 1 October 2018-31 January 2019 【Targets and number of subsidies】

From 1 to 13 years old as of the first day of the period: 2 times From 13 years old to the 3rd grade of junior high school: 1 time **【Subsidy】** 1,000 yen for 1 vaccination. Up to 3,600 yen for 1 vaccination for those who receive Public Assistance

【Things to bring】 Maternal and Child Health Handbook, Self-contribution cash, Health Insurance Card, Welfare

Benefit Recipient Card (for those who have Welfare Protection) *The Preliminary Medical Examination Card is available at cooperating medical institutions or can be downloaded from the city's HP.
