Child Allowance payment in June/Current State Report for Fiscal 2019

About the payment for June

«Date of payment» Scheduled for June 10th. There will be no payment notification card sent, therefore please confirm your account.

*The allowance paid will be for the period until May 2019. The amount of allowance for children who have graduated from junior high school in March 2019 will be paid for the period until March.

Current State Report

This is necessary in order for us to be able to confirm your situation as of June 1st and to evaluate if the requirements for the continued payments are fulfilled. The "Current State Report" form will be sent to the address of the recipient, therefore upon filling the necessary information, please submit it along with the required documents.

«Mailing of "Current State Report"» mid-June. It will be sent to address of the recipient.

«Submission»

- ♦By post: mail the documents to the City Hall Child Services Division until June 30th (Sun), 2019. (With postmark no later than this date)
- *Please use the reply envelope enclosed with the "Current State Report" form. (We kindly ask you to bear the postage stamp expenses)
- ♦ Submission in person: submission of documents at the City Hall Child Service Division or General Service Counter until June 30th (Sun), 2019. During a period of June 17th (Mon) − 24th (Mon) 9:00 − 17:00 on the 2nd floor of the City Hall a special venue for accepting the forms will be set. Reception at the counters is possible only on workdays, however on June 22nd (Sat) and 30th (Sun) reception will be open at the Children Services Division

as well. As reception counters tend to get extremely crowded, please come having sufficient amount of time.

Assistance in covering expenses for those using private after-school childcare centers

Issuance of subsidies aiming to alleviate an economic burden for households of guardians that are using privately managed childcare center and are subject to the Municipal Tax Exemption based on income as well as for guardians receiving payments for Livelihood Protection.

[Eligibility]: Guardians who have their Resident Registration in Tsukuba city and are subject to the Municipal Tax Exemption based on Income tax as well as households receiving payments for Livelihood Protection.

[Documents for Application]:

- ♦Written application (available at the Child Development Division counter or download it at the Tsukuba City's official website). After completing the form, please submit it directly to Child Development Division counter along with the documents listed below.
- ♦A copy of a document verifying a permission to use childcare center.
- ◆A consent form in reference to your tax situation (※For those who did not have Resident Registration in Tsukuba city as of 2018/2019 January 1st have to provide a Tax Exemption Certificate) as well as a copy of a document proving reception of payments for Livelihood Protection. [Application/Inquiry]: Child Development Division

<u>Marufuku renewal for single parent and for those with</u> severe and multiple disabilities

We will mail a new "Recipient Certificate" to people in concern. A notification will be sent to persons who have not yet declared their income or whose income cannot be confirmed, therefore people to whom it is applicable we kindly ask to complete the procedure within the given period.

Application for receiving National Health Insurance <u>Card for 2019</u>

The sending out of National Health Insurance Card for 2019 is scheduled to start from mid-July via simple registered mail. If for some reason, such as absence, you cannot accept the delivery and wish to receive the card at the City Hall counter, please apply for it in advance.

«Application» Until July 3rd (Wed) the head of the household is asked to apply by submitting "Request to retain insurance card" (the form is available at the National Health Insurance Division as well as at the General Service Counter). Please, have an identity verifying document for the proceeding.

«Available to collect» From July 22nd (Mon)

«Place/Time for collection» National Health Insurance

Division: from 8:30 AM until 5:15 PM

XExcept for Saturdays, Sundays and Public Holidays.

About the dates for the Municipal Tax payments for the period until the March 2020

We encourage the completion of tax payment until the due date. In case of having difficulties to cover the taxes, please consult before the expiry of the payment period. Tax Payment Notice will be delivered 2 weeks before the payment date. If by any chance the Notice would not be delivered, please contact relevant department in charge.

Municipal and Prefectural Taxes are paid by the residents residing in a particular municipality as of January 1st of that year. The taxes are calculated in proportion to income received in the preceding year, however, these taxes are not Income Tax.

****Property Tax** is paid by the persons who hold the ownership of land, house or depreciable assets (all of the aforementioned items are given the generic name of "Property") as of January 1st of that year. The payable taxes are calculated in proportion to the value of the property.

City Planning Tax is collected in order to carry out city planning projects as well as projects for land readjustment.
