## **Notice Regarding the F.Y. 2023 (Reiwa 5) Tsukuba City Price Inflation Assistance Benefits (¥50,000 per child) (Tax-exempt Households)**

In light of the increased burden caused by rising prices, the Japanese government has decided to provide Price Inflation Assistance Benefits amounting to ¥50,000 per child to households severely affected by surging costs (households exempt from residence tax).

**This notice is intended for households that moved into Tsukuba City on or after January 2, 2023 and do not have their FY2023 resident tax information recorded in Tsukuba City, as well as for households with separated living arrangements.**

Refer to the information below and the attached flyer, and **apply only if your household is eligible for the benefit.**

### **1. Beneficiary (head of household)**

- ① All members of the household must be exempt from per capita rate resident tax for F.Y. 2023 and meet the following conditions.
  - All members of the household are not dependent of individuals such as relatives who are subject to the residence tax.
  - There are no members in the household with undeclared income subject to the resident tax.
  - No members of the household have filed for exemption under a tax treaty.
- ② The applicant must be supporting (sharing the same household and finances) a child eligible to be included in the benefit as of the date of application.

### **2. Benefits**

¥50,000 per child

### **3. Procedures**

#### **[Application Form Instructions]**

- ① **Fill in everything within the red box for the head of household (applicant)**
- ② **Fill the names of all members of the household as of December 1, 2023 (in the red box)**  
※Those who do not know their individual number may leave the space blank.
- ③ **Fill the names of children eligible to be included in the benefit (children born between April 2, 2005 and June 28, 2024)**  
※Children born by June 28, 2024 are eligible for the benefit.
- ④ **Fill the bank account to receive the benefit (in the red box).**

**[Required documents] ※Make sure to fill out all the required information.**

- **Price Inflation Assistance Benefits Application Form**
- **Head of household's (applicant) identification documents**
- **Copy of document verifying the transfer account**

※Identification documents

With photo → one (1) document

without photo → two (2) documents

- If the head of household's resident registration is different from the child's resident registration (separate living arrangements), A copy of the child's residence certificate and identification document, as well as a petition, are required.

#### 4. Screening Results and Payment Date

Received applications will be reviewed in order of arrival. Decisions regarding the granting or denial will follow.

Benefits will be transferred three weeks to a month after receipt of the application. Please be advised that processing times may vary due to a high volume of applications and other factors.

Refer to the "Screening Result Notice" (決定通知書) that will be sent to each household to verify the screening outcome and payment date.
